TICKETING: Ticket sales are available at most stations; see website for ticket sales hours and approved vendors at www.acerail.com/Tickets/ticket-information. Tickets are also available for purchase online – instant tickets only for one-way/round-trips and are valid for 24 hours from date of travel at www.acerail.com/tickets. Please be aware of other delivery methods/periods for 20 trip and monthly passes by contacting customer service (Monday through Friday 4 AM. – 9 PM) at 1-800-411-RAIL (7245).

DISCOUNT RATES: ACE extends discounted ticket pricing for passengers with disabilities, Medicare card holders, seniors 65+ and children 6-12. For eligibility requirements, call 1-800-411-RAIL (7245) or visit www.acerail.com/Getting-You-There/FAQ/What-qualifies-as-a-discount-rider.

TICKET VALIDATION: One-way, round-trip and 20-trip tickets must be validated prior to boarding the train. Ticket validation machines are located at each station.

WHILE ON BOARD: Passengers must have their ticket available and displayed at all times. Upon request, present your ticket to the train crew for inspection as well as proof of discount eligibility for discount tickets.

CHILDREN: One child 5 and under free per paying adult. Children under the age of 12 are not permitted to travel without an adult in attendance.
